2 This Claim has an internal and external obligatory **form** , the internal one being through **imposition** , and the external one being through compliance with the Law wherever it may be, which corresponds to the Truth and **nothing** less than it!

3 All officially reported profits of the so-called "banks" in "Bulgaria" (because they are reported through the "BNB" and not to Sovereign) are official statistics of theft.

4 Even if the "recognition" of a Sovereign as the Sole and Legal Owner of this territory of the same name is **delayed** - **there is no** other Illegal (legal) state **after** 1992, **no** legal authority, **but** only a criminal "state" with criminal actions due to criminal intentions, because **there is nothing** else!

5 The authorities or the so-called "Bulgarian authorities" after 1992 had **the opportunity** to seek assistance in dealing with the problem of the "pig link" or tied hands (explained above) **abroad** from partner security services / which was **not** done!

6 Sovereign, **does not** express religious "holiness" or any other claim to bodily purity; is **not** a selfless, original, native talent of a "fighter" for the rights and freedoms of the human masses, **has no** such claim; **has no** connection with other people's opinion against the "special revolutionary operation" that began on August 31, 2023; **The Law** of Jupiter and the cow of "Bulgaria" before Europe, waiting for the Truth to work in the opposite direction to itself.
